**Item 3 Discuss Senate Bill 670 Provisions Regarding the Length of Election Term of the Board of Trustees.**

Superintendent McMinn explained that Senate Bill 670 give school districts a one time opportunity to change the Length of Election Term of the Board of Trustees. (See attached.) Mrs. McMinn commented that the change would bring stability in the District and the Board, would save the District money spent on personnel, judges, and equipment, and would avoid the operational disruption from late January to May. Mrs. McMinn reviewed Option 1 and Option 2 Resolutions:

**Option 1:** The current term of Place 1 shall be extended by one year to 2009  
The current term of Place 2 shall be extended by one year to 2009  
The current term of Place 3 shall be extended by one year to 2009  
The current term of Place 4 shall be extended by two years to 2011  
The current term of Place 5 shall be extended by two years to 2011  
The current term of Place 6 shall be extended by one year to 2011  
The current term of Place 7 shall be extended by one year to 2011

**Option 2:** The current term of Place 1 shall be extended by one year to 2009  
The current term of Place 2 shall be extended by one year to 2009  
The current term of Place 3 shall be extended by one year to 2009  
The current term of Place 5 shall be extended by two years to 2011  
The current term of Place 6 shall be extended by one year to 2011  
The current term of Place 7 shall be extended by one year to 2011
